HOW DO I WIN?

- Scores are determined by calculating how far under standard you are on your qualifying runs in Standard, JWW, and Time to Beat on Staurday and Sunday.
- Best possible score is if your qualifying run is clean and under time: you get points equal to 100% of the difference between your time and the standard course time (SCT). Example: SCT is 60; your time is 50. Difference is 10 points, you get 100% of that difference for a score of 10.
- If a qualifying run is NOT clean, you will lose points based on your score (a score of 95 means you earn 95% of the time under course time). Example: SCT is 60; your time is 50. Difference is 10 points, you get 95% of that difference for a score of 9.5.
- o If a run is clean but over time, you will get a "zero" for that run
- Scores will be input as class results are approved by the judges. If possible, intermediate results will be posted at the end of competition on Saturday.
- Final scores are determined by your cumulative time under the cumulative standard course times for all six classes

AWARDS / PRIZE GIVING

- Prize giving will be at the end of T2B on Sunday, Dec 28 and re-announced during the monring briefing on Monday, Dec 29. Please be present to pick up your award or arrange for someone to pick up it up for you.
