What is it? TDU practice runs, laid and aged to AKC specs, with as much or as little augmentation and coaching as you like, thanks to Meg Azevedo for being available. Being a practice, we can work with you if you want to volunteer/tracklay AND want to run a track. 6 tracks plus TWO alternate tracks if possible. Pizza will happen too. Plotting will happen Saturday Dec 17, and track running will happen Sunday Dec 18.

You want to come if:

- You & your dog could use more TDU (or VST!) tracking practice, in which we set you up for success.
- You think you might be ready to get your baby dog certified, we can do that here too, what a great chance to get certified ahead of the field test season! (Judges and evaluators will be present to certify.)
- You like to watch other dogs and handlers do tracking magic.
- You have always wanted to volunteer to tracklay at a test but have been shy of it, so this is a way to get your feet wet.
- You always wanted to try out judging! This is an excellent opportunity to get your feet wet THAT way too, Meg Azevedo has made it her personal mission to tempt more of our northern California tracking community to see if they might like to try judging – we need new blood!
