IMPORTANT NOTE TO EXHIBITORS:

MURIETA RELEASE FORM – REQUIRED

Murieta Equine Complex is now requiring all competitors to sign a release waiver in order to participate in events at MEC. There is a fillable pdf at the end of this premium list that you must complete and return with your entry UNLESS you entered the SDTC trials earlier this year. The waivers that you signed for those trials will carry over to this one.

MAIL ENTRIES TO THE SECRETARY'S PO BOX – NOT STREET ADDRESS. REGULAR MAIL ENTRIES WILL NOT BE ACCEPTED AT TRIAL SECRETARY'S HOME

The ONLY exceptions are OVERNIGHT entries. Express mail is brought to my door and not left in the box.

- If you provide an email address on your entry form, all future communications will be via email, including final confirmation information and judging schedule. Please make sure the Trial Secretary's email address: (kathie@touchngoagility.com) is allowed by your spam blocker. We will not resend or do any extra work to get your ISP to allow us to send messages to your email address.
- There will not be equipment familiarization at this trial.
- Move ups will be accepted until 6 pm Thursday, December 23, 2009. Day to day move ups will be accepted providing a move up form is completed and turned into the Trial Secretary on site within 30 minutes of the end of each day's trial. ENTRY FEES (PER DOG, PER DAY): $$16.00 - 1^{ST}$ Class; $$16.00 - 2^{nd}/3^{rd}$ class (includes AKC Recording Fees).
- SHOW SITE: This show will be held outdoors under cover on dirt. Ring dimensions will be 100 'by 110' per ring.

- Rosettes will be awarded to 1st through 4th place dogs with qualifying scores in each regular and preferred class and jump height.
- Prizes valued between \$2 and \$5 will be awarded to all dogs placing first through fourth in their class/jump height.
- Green Qualifying ribbons will be awarded to all dogs earning a qualifying score.
- Special Rosettes will be awarded to any dog completing a title or earning a "Double Q" from the Excellent B classes.
- Special Award for any dog completing a MACH. If you anticipate you may complete your MACH at our trial, PLEASE notify the Trial Secretary.

NOTICE TO EXHIBITORS

- * This trial is open to all dogs over the age of 15 months that are registered with the American Kennel Club or are registereable breeds that have obtained an ILP number from AKC, except bitches in season, aggressive dogs, blind or deaf dogs, or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance.
- * Running order will be determined by a random draw, and handlers with more than one dog will have those dogs separated as much as possible.
- * No hand delivery of entries within the first 24 hour of opening date and time. Maximum of 10 entries per envelope.
- * There will be no refunds for entries withdrawn after the closing date except in the event of injury to dog or handler or bitches in season. In these cases, entries will be refunded (minus expenses) provided the trial secretary is notified in writing prior to the trial. In the event a dog and/or handler are dismissed from competition, regardless of the reason for such a dismissal, there shall be no refund.
- * No entry fee will be refunded if this trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.
- * No umbrellas permitted on course during walk throughs
- * It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any fees paid will be made.
- * All dogs must be on leash at all times except when in the ring or when in the designated agility warm up area.
- * Exhibitors are responsible for being at the ring gate when it is their turn to run.
- * Exhibitors, while competing, must wear appropriate/proper footwear. Exhibitors will not be allowed to complete in "bare" feet or open toe shoes.
- * Returned checks do not constitute a valid entry. The Trial Secretary will add a \$25.00 collection fee to the amount of each returned check (this is the amount charged by our bank for returned checks). Subsequent returned checks from the same exhibitor will result in their being put on a "cash only" basis.
- * Please clean up after your dog. Let's show them that "Dog People" are clean people.
- * DO NOT LEAVE ANIMALS UNATTENDED IN VEHICLES. The club will not be responsible for damage to vehicles resulting from the rescue of animals in distress.

AGILITY TRIAL SITE AND ACCOMODATIONS

SITE: Murieta Equine Center, 7200 Lone Pine Drive, Rancho Murieta, CA 95683 This site is outdoors undercover on rolled packed dirt. There will be two 110' x 100' rings.

DIRECTIONS:

From Sacramento/Bay Area: Take Hwy 50 east towards Lake Tahoe. Exit at Sunrise Blvd. Turn right off the exit ramp and proceed for 7.4 miles to Jackson Rd (Hwy 16). Turn left on Jackson Road and proceed 7.1 miles to Lone Pine Rd. Turn right on Lone Pine. Murieta Equine Complex is immediately on your right.

ENTRY REQUIREMENTS: REGULAR TITLING CLASS

Novice A – For persons and dogs that have NEVER acquired an AKC agility title.

Novice B – For dogs that have acquired an agility title, persons that have handled a dog to an agility title, and for agility judges. Open – For dogs that have acquired the Novice or Open titles, but have not earned a qualifying score in the Excellent class. Excellent A – For dogs that have acquired the Open title, but have not completed the Excellent title.

Excellent B – For dogs that have acquired the Excellent title.

ENTRY REQUIREMENTS: PREFERRED TITLING CLASSES

Open to any dog eligible to enter an agility trial as defined in AKC Agility Trial regulations. Dogs may be entered in either Preferred class or the Regular class at any trial. The dog must be entered ONLY in Preferred or Regular classes, with no crossover between them being allowed at the same set of trials. So, if you want to enter your dog in Preferred classes on Sat, you must also enter Preferred on Sunday, Monday, and Tuesday.

Novice – All dogs entering the Preferred Classes **for** the first time must enter the Novice level regardless of the previous titles. Novice Preferred is NOT split into A and B divisions.

Open – For dogs that have acquired the Novice Preferred or Open Preferred titles, but have not earned a qualifying score in the Excellent Preferred class.

Excellent A – For dogs that have acquired the Open Preferred title, but have not completed the Excellent Preferred title.

Excellent B – For dogs that have completed the Excellent Preferred title.

ENTRY REQUIREMENTS: F.A.S.T. - Fifteen and Send Time

The focus of the FAST class is to test the skill, timing and distance work involved in a game of strategy and point accumulation.

Novice A – For persons and dogs that have NEVER acquired an agility title.

Novice B – For dogs that have acquired an agility title, persons that have handled a dog to an agility title, and for agility judges. Open – For dogs that have acquired the Novice or Open titles, but have not earned a qualifying score in the Excellent class.

Excellent A - For dogs that have acquired the Open title, but have not completed the Excellent title.

Excellent B – For dogs that have acquired the Excellent title.

NEW AKC RULES EFFECTIVE SEPTEMBER 1, 2010

Highlights:

- AFrame for 4" and 8" dogs has been lowered to 5'.
- Table no specific position is required.
- Tire Jump has been lowered 4" for each height class
- Dog Walk up contact will not be judged
- Weave Poles If the dog "pops" out of the poles, poles must be restarted at the first pole. Dogs may not fix the poles from the beginning. Dogs are given 3 attempts then must go on.
- Standard Course Times have been changed for the 8" and 24" classes.

Wait List: Two Rivers Agility Club of Sacramento is offering a Wait List to fill openings created by withdrawn entries after the trials closing date. A maximum of 100 runs will be placed on the club's wait list. All entries, including wait listed entries, must be received by the Trial Secretary prior to 6:00 pm on December 24, 2010. Any entries withdrawn that are received by 6:00 pm on December 24, 2010 will be replaced by a wait listed entry if any are available. If a withdrawn entry is replaced by a wait list entry, a full refund less a \$5 processing fee will be issued to the withdrawn entry. Any wait listed entry that does not move off the wait list into the trial by 6:00 pm on December 24, 2010 will receive a full refund.

AGREEMENT

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lesser of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting there from, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other person. I (WE) AGREE THAT ANY CAUSE OF ACTION, CONTROVERSY OR CLAIM ARISING OUT OF OR RELATED TO THE ENTRY, EXHIBITION OR ATTENDANCE AT THE EVENT BETWEEN THE AKC AND THE EVENT-GIVING CLUB (UNLESS OTHERWISE STATED IN ITS PREMIUM LIST) AND MYSELF (OURSELVES) OR AS TO THE CONSTRUCTION, INTREPRETATION AND EFFECT OF THIS AGREEMENT SHALL BE SETTLED BY ARBITRATION PURSUANT TO THE APPLICABLE RULES OF THE AMERICAN ARBITRATION ASSOCIATION. HOWEVER, PRIOR TO ARBIRATION ALL APPLICABLE AKC BYLAWS, RULES, REGULATIONS AND PROCEDURES MUST FIRST BE FOLLOWED AS SET FORTH IN THE AKC CHARTER AND BYLAWS, RULES, REGULATIONS, PUBLISHED POLICIES AND GUIDELINES.

INSTRUCTIONS

Handlers may opt to enter in a higher **height division** for all **Regular** titling classes, but not in a division lower than their proper height division. Dogs entered in the **Preferred** classes <u>must</u> compete at the required jump height and <u>may not</u> compete in a jump height division <u>higher or lower</u> then their proper height division.

All dogs that have not been officially measured for an **Agility Jump Height Card** may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or *back-to-back trials* only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs enrolled in the **AKC Canine Partners Program**SM may be eligible to enter all-breed AKC agility trials at the club's option effective April 1, 2010. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler Number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 816-3776. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner?

I CERTIFY that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name I have entered above.
