This is a preliminary judging schedule which is contingent on move-up entries not yet received. Upon acceptance of your entry, you were emailed an entry confirmation. No additions, deletions, or changes may be made after closing except for move ups or in a wait list situation. <u>Move ups for Friday</u>, <u>Dec 27, 2019 are accepted until Monday</u>, <u>Dec 23, 2019 at 11:59 pm and must be in print (either letter or email)</u>.</u> Move ups for Saturday, Sunday and Monday will be accepted until 15 minutes after the close of day's event.

IMPORTANT EXHIBITOR NOTES

MURIETA EQUESTRIAN CENTER IS FIRST AND FOREMOST AN EQUINE FACILITY. THIS MEANS THE HORSES ARE THE MOST IMPORTANT ANIMALS THERE. DOGS MAY NOT BE OFF LEASH <u>ANYWHERE</u> ON THE GROUNDS EXCEPT IN THE MAIN ARENA.

ANY DOGS FOUND TO BE OFF LEASH AND CHASING, SCARING, OR OTHERWISE HARRASSING THE HORSES RISK EXPULSION FROM THE EVENT AND THEIR HANDLERS RISK A BENCH COMMITTEE HEARING FOR POTENTIALLY CAUSING ALL AGILITY CLUBS TO LOSE ACCESS TO THIS SITE.

DO NOT, under any circumstances, allow or encourage your dog to relieve itself anywhere under, in or on the arena floor, structure, or anything man- made anywhere on the site.

Additionally, be sure to pick up after your dogs regardless of where or when they leave a mess. At recent shows, we have all picked up many, many piles of dog

droppings. We don't KNOW that they are from agility competitors, but we will be blamed, regardless of who leaves them.

TRACS is a small, but active club. We host AKC, USDAA, and UKI agility trials as well as AKC Tracking tests throughout the year. TRACS ANNUAL MEETING

TRACS will be having our annual meeting on Thursday afternoon immediately following set up (approximately 4:00 pm). The meeting will take place in a location to be determined at set up.

DIRECTIONS TO THE SITE:

<u>From Sacramento/Bay Area and other points west/south</u>: Take Hwy 50 east towards Lake Tahoe. Exit at Sunrise Blvd. Turn right off the exit ramp and proceed for 7.4 miles to Jackson Road (Rt 16). Turn left on Jackson Road and proceed 7.1 miles to Lone Pine Rd. Turn right on Lone Pine. Murieta Equine Complex is immediately on your right.

<u>From Reno</u>: Take Hwy 80 towards Sacramento. Exit at Sierra College Blvd. Turn south. Sierra College Blvd becomes Hazel Ave. Follow Hazel Ave to Hwy 50 west. Follow Hwy 50 to Sunrise Blvd exit. Turn left off exit ramp and follow directions above.

SET UP NOTES:

- TRIAL SET UP STARTS AT 1:00 PM ON THURSDAY, DECEMBER 26, 2019.

- SET UP VOLUNTEERS MAY LAY THEIR MATS DOWN AFTER 12:30 PM.

- VENDORS MAY SET UP AFTER 1:00 PM

GENERAL EXHIBITOR SETUP STARTS AT 3:00 PM

Anyone setting up prior to that time will be asked to stop, move or be moved until we get the show set up or 3:00 pm, whichever is later.

SET UP:

GENERAL EXHIBITOR set up starts at 3 pm.

However, if you are willing to help us set up the trial, TRACS will be setting up the trial starting at approximately 1:00 pm and would love to have your help! Please contact Terry LeClair (<u>tleclair101@gmail.com</u>) to volunteer to help. Those helping to set up may arrive around 12:30 pm and toss down your mat (see notes on crating below), then start helping with the set up. Once we get the trial all set up, trailers unloaded, equipment assembled, and courses built, THEN you can complete your set up. IF you are helping with set up, you may take space for yourself and one friend ONLY prior to 1:00 pm general set up time.

DAY PARKING: Due to limited space, and as a thank you to our hard working TRACS keyworkers, parking along the edge of the Main Arena to the north IF ANY is available will be reserved for TRACS Trial Committee and Keyworkers. Please respect these reserved areas. They will be marked off early on Thursday morning. There is NO exhibitor parking in between the Arena 1 (the Main Arena) Arena 2.

Exhibitors may park anywhere else that is not a fire lane or otherwise indicated by "no parking" signs. DO NOT move any barriers that have been set by Murieta or by TRACS.

CRATING:

PLATFORM AREA IS RESERVED CRATING SPACE:

- The raised platform area at the west end of the arena (near the office) is reserved for TRACS members and for assigned vendor set ups.
- Vendors spaces will be identified during trial set up and some of these will be on the Platform.
- Members who are helping with trial set up have first shot at this space.
- Members may reserve space for one friend PROVIDED those friends are prepared to support our club by working throughout the weekend.
- You MUST lay a mat down under any set up on the platform.
- At the discretion of the Trial Chair, once all TRACS members have had an opportunity to get set up on the platform area, any remaining space on the platform will be opened for general crating.

There is a walkthrough gate about halfway down the exposed set up area and the rings. To prevent congestion and possible dog on dog issues, do not set up within 5 feet either side of the gate on the crating side of the wall. See map for an illustration.

Please check out the attached site map to get an idea of where you will be able to crate this year. There will be no crating in between rings or along the wall on the entrance side of the wall near the rings. <u>CRATING IS NO LONGER PERMITTED ON THE SECOND FLOOR</u> <u>OVERLOOKING THE ARENA</u>. If you are setting up ex-pens, which is fine, please be prepared to be extra friendly with others, especially on the ground floor platform area. This issue will become especially important if we have inclement weather which may reduce the amount of crating space. The Trial Committee reserves the right to require people to reduce their crating area to the minimum needed for crates and ex-pens if conditions warrant.

UNATTENDED DOGS: In accordance with AKC rules, all dogs must be on leash and attached to a

human being. Please do not tie your dog to the fences, leave them in chairs, or in an unattended down stay next to the ring while walking your course. If you are early in the running order, you may bring a crate to the warm up area to stage your dog so you can be ready immediately following the walk though. However, you will have to remove it after your run to keep congestion down near the front of the rings.

ATTENTION RV OWNERS STAYING ON SITE:

IF LEFT OUTSIDE THE RVS, WHETHER THE OWNERS ARE THERE OR NOT, ALL DOGS MUST BE CONFINED IN AN EXERCISE PEN / YARD OR CRATES. NO DOGS MAY BE TETHERED OR TIED OUT. THERE IS TOO GREAT A RISK OF SPOOKING A HORSE COMING BY IF THE DOGS BOLT TOWARDS THE ROAD, EVEN IF THEY CANNOT REACH THE ROAD

<u>RV PARKING</u>: TRACS has no involvement with RV parking/camping reservations. Contact Murieta Equine Center at (916)985-7334. Except by prior arrangement, there is NO overnight RV parking north of the main arena.

<u>USE OF GENERATORS</u>: Unless necessary for the conduct of the trial, there may not be any generators running near the main arena except between the hours of 6:00 - 7:00 am and 60 minutes after the last dog runs. Additionally, the trial committee reserves the right to require ANY generator be shut down if exhaust fumes are causing problems.

<u>FOOD</u>: The Murieta Café will be open all days of the trial. Confirmed hours are 8:00 am through 4:00 pm. See the menu later in this letter for details. You may use the worker tickets at the Murieta Café.

Additionally, there is a Espresso Vendor in a trailer parked on the south side of the Arena, on the same side as the New Murieta Cafe and the newer bathrooms. He will be open at 7:00 am each day. You may NOT use the worker tickets for the coffee

Also, TRACS will be providing complimentary coffee, muffins, and fruit to competitors in the hospitality area until 10:00 am.

FIRST AID: There will be both human and canine first aid kits available on the First Aid table tentatively located on the platform, near the office.

<u>WORKERS</u>: We are not doing advanced worker scheduling. There will be white boards to sign up to work the various classes. So, if you see a gap, please sign up to help. Every class you work in will earn you raffle tickets for our awesome Workers Raffle as well as a \$2 voucher for each class / division worked (not to mention the undying gratitude of our hard working Ring Crew Chiefs). If your Ring Crew Chief doesn't give you raffle tickets or \$2 vouchers, don't be shy—ask for them!

<u>HELP NEEDED EACH DAY AT END OF JUDGING</u>: In order to provide our exhibitors with the best possible footing for your dogs, TRACS will be clearing the rings of equipment EACH NIGHT immediately following the last run in order to water and re-grade/drag the ring. Last year, we found that by doing this it built up soil moisture over the course of the trial and conditions kept improving. PLEASE, PLEASE, PLEASE!! Our course builders (who have been working hard all day) will need help to clear the rings by moving equipment to the center aisle. Help will be greatly appreciated and you can earn raffle tickets for the following days' awesome worker raffle.

<u>COURSE BUILDING HELP</u>: Although we have a cadre of very hard-working course builders, four days a is LONG time and there are a lot of courses to build. Please, feel free to jump in and volunteer to help set/change courses. If you have never built courses before, check out the page towards the end of this judging schedule. It gives a list of tasks that you can do to help the course builders and

don't take any prior experience. If you would like to learn more about course building, we can arrange to have one of our course builders mentor you and show you the ropes.

<u>VOUCHER EXCHANGE</u>: Your worker vouchers can be used at the Murieta Café (the Snack bar) or with any vendor on site (during the trial only). Any vouchers you have not used by the end of the trial <u>must</u> be exchanged for a TRACS certificate. Just bring them to the Scoring Office and we will take care of you! These certificates will be good for future TRACS entries (either AKC, USDAA, or UKI). <u>Remember: The \$1/\$2 tickets will have NO value after the event.</u>

<u>SCORING, QUESTIONS, POSTING</u>: Scores will be posted in binders outside the scoring office and near awards as soon as possible after each jump height is completed. Please check your results as soon as possible so we may resolve any questions you may have before the judge forgets what your run was like! If you have a question, come into the office and ask. While it's true the score room is busy, we are never too busy to help you. However, we do ask that you do not bring dogs into the Scoring Office.

If you have any questions about anything other than scoring, or have any feedback about ways we can improve our trial don't be shy about saying something (although I've never really known agility people to be shy about expressing their opinions). Track down our Trial Chair, Terry LeClair; our Trial Co-Chair, Debbie Thompson; our Trial Secretary, Kathie Leggett; or talk to anyone wearing a red or black TRACS shirt/jacket.

<u>AWARDS</u>: We will have your awards ready as soon as we can, but please be patient. AKC requires judges to review all scribesheets prior to awards being available to competitors. In addition to ribbons for class placements and qualifying flats, there are special rosettes for Double Qualifying rounds; for new titles; and for any MACH. <u>IF YOU MIGHT EARN A GRAND CHAMPIONSHIP, MACH, OR</u> <u>PACH AT THIS TRIAL, PLEASE LET OUR TRIAL SECRETARY KNOW AS SOON AS POSSIBLE!!</u>

<u>CHECK IN</u>: There will NOT be armband number stickers at this event. Remember that if your dog needs to be measured, you MUST have them measured before you run your first run of the weekend. Most course maps will be available on the check in table outside the scoring office for pick up. Open and Novice FAST maps will be available on the shelf just inside the door of the scoring office. If you are entered in those classes, come in and ask for them.

<u>MEASURING</u>: The only dogs that require measuring are those without height cards or dogs over two years of age who only have one measurement. If you have a permanent height card or two measurements on a dog more than two years old or have a temporary height card for dogs less than two years old, you no longer need to submit or show height cards.

OFFICIAL HEIGHT CARD MEASUREMENTS: We will have Volunteer Measuring Officials for the weekend. Our three measuring officials will be Cindy Macklin, Beverly Morgan Lewis, and Kathie Leggett. Official measuring will be done at the beginning of the trial and approximately at the top of each hour during the trial. If you need a height measurement (and remember that dogs over two years of age without permanent height cards at this time need at least two measurements), fill out your paperwork (available at the trial), and let the office know you are looking for a measuring official.

<u>RESTRICTIONS ON VENDING/SELLING STUFF</u>: In order to sell anything, anywhere on the trial grounds, you must pay Murieta a per day vendor fee plus carry a \$1,000,000 insurance policy (and have proof insurance with you on the grounds). Anyone selling anything must set up in area designated by or coordinated with the Vendor Chair, Terry LeClair. You can reach him at tleclair101@gmail.com. This includes selling stuff from your crating area. Please do not jeopardize our good relations with Murieta by not following these requirements. This is not a TRACS requirement, but one set by Murieta Equine Center.

TRIAL SCHEDULE - Please see details on the following pages!

<u>CONFLICTS</u>: Conflicts will be handled as needed. If you even THINK you might have a conflict, be sure to mark a "C" next to your name on the gate boards if there is no Gate Steward present. Per AKC rules, only the JUDGE can approve changes in running order, In addition to the Gate Stewards, our Judges have delegated the authority to make changes in the running orders to the following individuals:

Terry LeClair; Debby Thompson; Kathie Leggett; Sandy Zajkowski; Vickey Meyer; Julia O'Rourke; Karen Johnson

We will do everything we can to make sure you get your run, including resetting jump heights <u>once</u> after all dogs have run, so long as you have told us you have a problem. However, we will not hold a ring open once all dogs present at ringside have run; there are other classes to get going.

REMEMBER: A GOOD RULE OF THUMB IS ALWAYS RUN THE SMALLER CLASS FIRST AND MARK A CONFLICT FOR THE LARGER CLASS WHERE THERE ARE MORE DOGS TO RUN AND POSSIBLY ADDITIONAL WALK THRUS!

<u>MOVE UPS</u>: Pre-trial move ups will be accepted until 12 noon Mon, Dec 23, 2019. Day-to-day move ups will also be taken provided you have completed a move up form (you will find them near the results binders) and given it to the Scoring Office within 15 minutes of the final run of the trial. It's really helpful to the scoring team if you do this as soon as the official results show you are eligible to move up. But it MUST be no later than 15 minutes after the end of the final class of the day.

<u>LIVE TO RUN AGAIN LIBRARY</u>: Will be at this trial. Feel free to borrow a book on tape (audio CD's or cassettes) or contribute to the library. If you are donating a new audiobook, please give it to Penny Larson so she can process it before adding it to the library. You don't have to put one in to take one out-just return it when you are done at the next trial and borrow another. Open to everyone.

<u>NOTE from the LTRA Custodian</u>: Please remember this is a LIBRARY! Please check around your car and home for audio books you may have borrowed and return them to the library box. Thanks.

PLEASE READ THE FOLLOWING INFORMATION VERY CAREFULLY. WE HAVE SET THE SCHEDULE TO BEST REDUCE CONFLICTS THROUGHOUT THE TRIAL. JUMP HEIGHT ORDER CHANGES DAILY, ESPECIALLY IN THE MASTER / EXCELLENT CLASSES.

FAILURE TO READ AND UNDERSTAND THE SCHEDULE IS NOT GROUNDS FOR RUNNING OUT OF ORDER.

On Monday, there are only two groups, and those groups are: Group 1: 16/12/8/4 Group 2: 24C/24/20

We will do our best to stick to this, however, if necessary, in the Masters/Excellent classes, jump height order may change if it makes the trial more efficiently. Listen for announcements!!! See next page for running order/jump height order specifics.




