

RV and Overnight Information TRACS ASCA 2010

General Information

The Primary Camp hosts are Ron & Barb Avila (primary phone #: 510-366-8544; alternate phone #: 510-366-1418).

Assigned Camp Sites

Camp sites have been **pre-assigned**. The Master list of assignments and a RV Map of the Fairgrounds will be provided by email/online. Copies will be available at check-in if needed.

Parking Permits

There is a Check-In table at Site #8. **Please pick-up your Parking Permits before you park. Do not make us chase you down!!** The permit must be displayed at all times in all vehicles associated with your site.

Locating and Parking at the Site

Each site has an orange flag with a number. This flag represents the left edge of your site. It should be on the **left side as you face the site**. This provides the ability of the driver to view the flag as they enter the site. There may be spray paint designating your exact parking spot.

Tents and Vehicles without Utilities

The Tent and small vehicle overnight campers not using utilities have assigned sites. Large vehicle without utilities such as trailers, A or B/C have been assigned an area away from the tents. As you have chosen not to pay for electric, this means you may not plug into any outlet for any reason; this includes plugging into a friend's RV if they have paid for power.

Generators

Anyone using a generator must have an exhaust pipe from the generator to a spot over the roof of the RV/trailer.

Parking around the Rings

People parking around the sides of the rings must be gracious in providing space for crates chairs etc of people not directly around the ring.

Towed & Extra Vehicle Parking

If the vehicle doesn't fit within your site it can be parked in the area on the east side of the Open Arena (see map). Trailers and 5th wheels may need to unhook and park separately.

Morning arrivals during the show days should realize that all vehicles must be on site and parked by 7:30am. Follow the normal check-in procedure.

Thursday Arrivals

Thursday at **2pm** is the time we will open the gates for RV and camper overnight parking.

4:00 PM -- You MAY NOT setup canopies ringside before 4:00 pm when everyone else is permitted in.

NO Staking Permitted

We are not permitted to stake into the ground Canopies or tents or awnings. This means using sand bags, coffee cans with cement, plastic bags with water etc. Please see the email from Kathie Leggett for more detailed information. Friday/Saturday/Sunday-AKC show exhibitors

If you are going to be arriving **during the show** you will need to be prepared to **wait outside** until the show is finished for the day. If the outside parking lot is full use the lot across the street from the fairgrounds. DO NOT enter while the show is in progress.

When the show has completed for the day we will permit access to the grounds and you can follow the normal check-in procedure.

Friday/Saturday/Sunday-ASCA show exhibitors

Please use the back gate that you access off of Chestnut St. To do this proceed East on Chestnut (the fairground is on your right) until you reach the end of the fence. Make a right turn and then an immediate right into the fairground. Proceed slowly until you reach the outdoor horse arena and stop. Contact Leslie Fassio (707-321-2041) and she will show you to your site. If she isn't available contact Ron or Barb Avila (510-366-8544) and they will show you to your site.

Exiting the Fairgrounds

Each afternoon and evening there will be some people leaving the show. On Thursday and Friday the rear gate will be opened so that you can depart without disturbing other people. However, on Saturday and Sunday the ASCA show will be ongoing all day and you must be prepared to depart through the main gates. If you must depart while the rings are running please exercise extreme care.

On Monday there will be many people leaving the show. The rear exit will be open so that the RV's and overnight campers can leave and not be in conflict with the day timers dismantling their setups.

Utilities

Every attempt is being made to provide the electrical connections requested. But, we are not responsible for the fairground facility and it is possible that you could need to use a different amperage, (30 rather than 50, 20 rather than 30) than requested so please bring any and all converters that you have. A long extension cord could be necessary.

Water and sewer are scarce. There will be a place you can take on water and dump if that is necessary

Showers

The showers occasionally run out of hot water. It would be best if you conserved hot water so there will be more to go around. Also, if possible you may want to shower throughout the day so that there isn't a line.

Other Users of the Fairgrounds

During the week Thurs. and Friday there is a school that uses one of the fairgrounds buildings. At recess the children play in the north area and sometimes wander the grounds.
