NOTICE TO EXHIBITORS

Wait List: Two Rivers Agility Club of Sacramento is offering a Wait List to fill openings created by withdrawn entries after the trials closing date. A maximum of 100 runs will be placed on the club's wait list. All entries, including wait listed entries, must be received by the Trial Secretary prior to 11:00 pm on May 11, 2018. Any entries withdrawn that have been received by 11:00 pm on May 11, 2018 will be replaced by a wait listed entry if any are available. If a withdrawn entry is replaced by a wait list entry, a full refund less a \$5 processing fee will be issued to the withdrawn entry. Any wait listed entry that does not move off the wait list into the trial by 6:00 pm on Monday, May 21, 2018 will receive a full refund.

- This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds.
- Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations it includes both sexes.

- Dogs should be physically sound. Dogs that are blind or deaf shall not be eligible and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate. Puppies under four months of age are strictly prohibited from the trial grounds.
- Mixed breed dogs that have been listed with AKC Canine Partners may participate provided their listing number has been recorded on the entry form and must list "Canine Partner" (mixed breed) for the breed name on the entry form. No other breed description may be used to identify a mixed breed entry. Additionally, the exhibitor must provide their AKC Canine Partners listing number on the entry form and check-mark "AKC No."
- Running order will be determined by a random draw. Handlers with more than one dog will have those dogs separated as much as possible.

ENTRY REQUIREMENTS: INTERNATIONAL SWEEPSTAKES CLASSES:

Purpose: The International Sweepstakes Class (ISC) is a non regular class providing the dog and handler an opportunity to demonstrate their advanced training and handling skills on various International Style Standard and Jumpers with Weaves courses. The rules for this class are generally based on international rules. The variety in International Agility course designs is very diverse, so handlers should be prepared to meet the "Challenge of the Day" when competing in the ISC class. The total challenge level may be easier, more difficult, or simply different from what is currently allowed in Excellent / Master Class. Complete rules for the ISC are available from the AKC Website (http://www.akc.org).

Eligibility: This class is open ONLY to dogs that are eligible to compete in BOTH the Excellent / Master Standard Class AND the Excellent / Master Jumpers with Weaves Class. There is no Preferred Option for ISC; dogs may enter at their preferred jump height, however they will be scored against the regular division dogs jumping the same jump height.

Jump Heights: Dogs may be entered in their regular jump height, however, only those dogs in the 12 & 16" class that meet the FCI/ISC measuring cutoff (different than regular AKC cutoffs), or any dog entering the 24" jump height will be eligible for the direct invitation to the 2018 World Team Tryouts.

> Small (12" jump height) – for dogs measuring 13 ¾" and/or less at the withers Medium (16" jump height) – for dogs measuring over 13 ¾" but 16 7/8" or less Large (24" jump height) – for dog measuring over 16 7/8"

ENTRY REQUIREMENTS: PREMIER STANDARD AND JWW:

PURPOSE: These optional titling classes are designed to challenge dogs and handlers at an increased speed and skill level above those set for the Master level classes. Handlers/dogs will need to negotiate courses that required varied approach angles, spacing and obstacle discriminations to be successful in these classes. These classes are offered as separate titling tracks and are not part of the MACH/PACH Championships, however, these classes ARE part of the new GRAND CHAMPIONSHIP title as well as they can be used to fulfill some AKC Nationals Qualifying requirements.

ELIGIBILITY REQUIREMENTS: Dogs with an AX are eligible to enter Premier Standard Regular. Dogs with an AX or AXP are eligible to enter Premier Standard Preferred. Dogs with an AXJ are eligible to enter Premier Jumpers with Weaves Regular. Dogs with an AXJ or AJP are eligible to enter Premier Jumpers with Weaves. Dog with Regular titles may crossover to the Premier Preferred level as noted above.

HEIGHT DIVISION CHART

Exhibitors may opt to enter in a higher height division for all Regular titling classes, but not in a division lower than their proper height division. Dogs entered in the Preferred classes <u>must</u> compete at the required jump height and <u>may not</u> compete in a jump height division <u>higher or lower</u> than their proper height division. Owners are responsible for entering the proper height divisions. If your dog has been measured by an AKC Field Representative or Volunteer Measuring Official (VMO) and is now eligible to jump in a lower height class, the measurement is effective immediately including any runs (regular or preferred class) which have not yet occurred on the same day that the measurement is recorded. This immediate action does not apply to measurements taken as part of completing the challenge measurement process. Dogs who measure into a higher jump height have always been required to be moved immediately. Dogs measuring over 22" at the shoulder are not eligible to enter 24" Choice.

RVs arriving prior to Thursday, May 24th risk having to move to their assigned parking spot on Thursday afternoon. If arriving Thursday, please do not arrive prior to 2 pm.

The fee for RV parking remains \$35 per night.

The fee for tent campers or vans not using utilities is now \$20 per night.

INSTRUCTIONS

Handlers whose dogs measure into the 8" through 20" regular jump height divisions may opt to enter in a higher or 24-choice height division for all Regular titling classes, but not in a division lower than their proper height division. Dogs who measure into the 24" regular jump height division. may not enter 24-choice. Dogs entered in the Preferred classes must compete at the required jump height and may not compete in a jump height division higher or lower than their proper height division.

All dogs that have not been officially measured for an Agility Jump Height Card may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or back-to-back trials only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the AKC Canine PartnersSM program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner?
