AGREEMENT

By signing this agreement, I acknowledge that I have the authority to do so as an exhibitor or owner of the dog(s) I have entered in this event. I further acknowledge that I am familiar with the rules and regulations of this sport and that my dog(s) are familiar with and able to perform all obstacles safely.

Additionally, I affirm that all dogs I bring to the event, whether participating or not, do not present a hazard to persons, dogs, or property. I assume sole responsibility for the dog(s) I bring to the event, and I assume all responsibility, liability, and expenses resulting from any damages caused by my dog(s).

I, for myself and my heirs, specifically release, waive, discharge, and covenant not to sue the American Kennel Club, NORCAL Golden Retriever Club, Two Rivers Agility Club of Sacramento, the event facility owner, and all members, agents, officers, directors, employees, vendors, judges, and volunteers of the foregoing entities ("Released Parties"), from or for any and all liability, claims, demands, actions, and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me or my dog(s) while participating in the event, whether or not caused by any of the Released Parties.

I agree to indemnify, defend, and hold harmless the Released Parties from and against any and all losses, damages, liabilities, claims, actions, judgments, costs, and expenses (including reasonable legal fees) caused by or resulting from my participation in the event.

I understand the event may involve certain risks, including but not limited to, bodily injury, personal injury, illness, and/or death to me or my dog(s). I also acknowledge all hazards present at the event facility, including the condition of the premises, the condition of grounds, condition of agility equipment, lighting, security, electrical appliances, fittings, parking areas or fences. I understand and assume the risk of encountering an ill animal or person or allowing my dog(s) to escape from the event area. I also assume the risk of injury from allowing my dog(s) to run wearing collars, stop pad protectors, bitch-in-season pants or similar items. I understand that I must monitor my dog(s) on the event property and maintain good animal hygiene. I voluntarily assume full responsibility for any risks of loss, property damage, or personal injury, including death, that may be sustained by me or my dog as a result of participating in the event. If anything in this Agreement is found to be unenforceable, the remaining terms and provisions shall remain in full force and effect.

NORCAL Golden Retriever Club reserves the right to excuse any dog we feel poses a threat to people or other dogs present at the event or who is unable to perform the obstacles safely. We also have the right to excuse any person for aggressive or abusive behavior toward another person or dog, as determined by an appropriate official.

By entering this event, I acknowledge that compliance with these rules is my responsibility.
