



- On the Master Exhibitors List tab, enter the Dog and Owner's information from the entry forms. PLEASE be sure this information is accurate and complete so that the integrity of the results are protected!
- Using the four (4) tabs below, enter the Owner's Name, Dog's Call Name, Breed, and AKC Reg # (if assigned), along with what jump height the handler wants their dog to jump. A dog may be entered in any jump height desired. Click the "Add A Row" button if more lines are needed for entrants. Click the "Sort by JH-CallName" to create the running order. Enter each Dog's Run Time and # of faults as judged by the evaluator, using NT for No Time. Click the "Calc Q/NQ" to calculate both Q/NQ and placements (if the club has chosen to offer placements).
