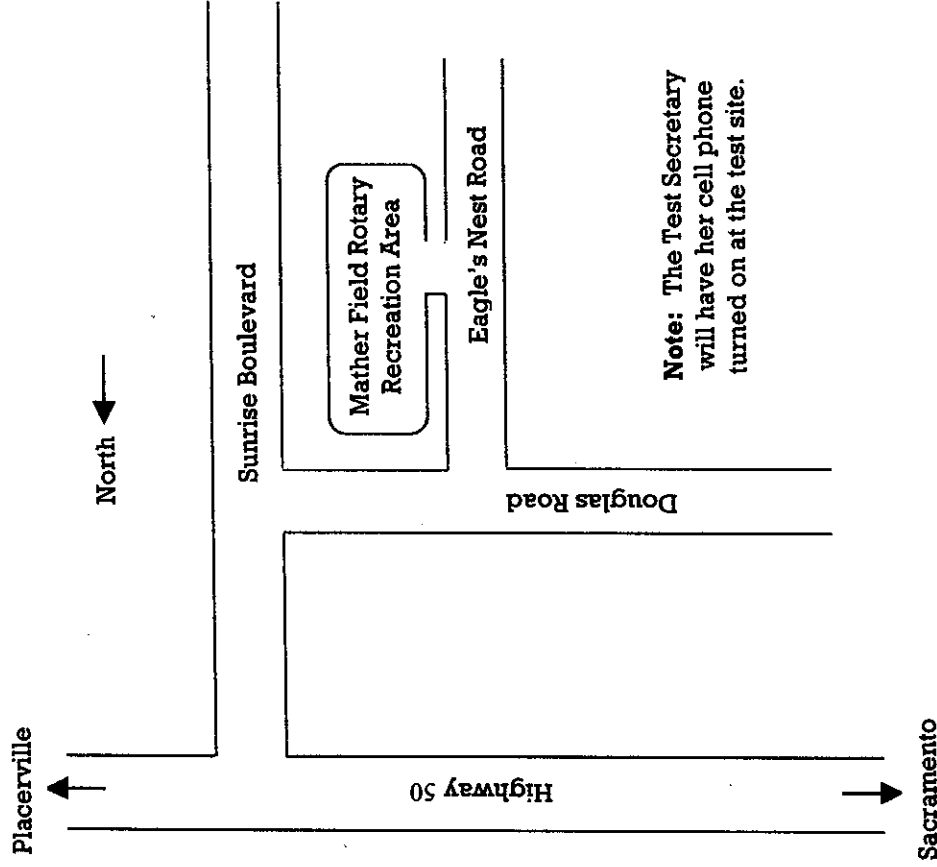
Tracking Test Entries: Entries are limited to 12 dogs. Dogs holding the title of Tracking Dog shall not be barred from competition; however, the Test Secretary will give dogs not having a TD preference.

Entry Fee: \$40.00 payable in US dollars. A \$.50 AKC recording fee and \$1.50 event fee is included in each entry and will be forwarded to the AKC per CH 11, Sec. 2 of the AKC Rules and Regulations. Make checks payable to TRACS.

Directions: From Sacramento take Highway 50 East towards Placerville. Take the Sunrise Boulevard South exit and go 4 miles to Douglas Road. Turn right onto Douglas Road and go 1 mile to Eagle's Nest Road. Turn left onto Eagles Nest Road. Go 2/10 mile and turn left into Mather Field Rotary Recreation Area, where we will meet for the draw. From Placerville take Highway 50 West towards Sacramento and follow the above directions.

Certification: An original written statement must accompany each entry for a licensed or member tracking test for any dog, which has not previously passed an AKC TD test. This statement must be dated within one year of the date the test is to be held, signed by a person approved by the AKC to judge tracking tests, and must certify that the dog has satisfactorily performed a certification test.

The Draw: A random drawing of all entries received by the closing time and date to determine which entries will participate in the test will take place on Thursday, February 10th at 7:00 PM at the Burger King Restaurant, located at the corner of Mace Blvd and Chiles Road, Davis, CA.

Alternate List: An alternate list will be maintained and will consist of entries received by the closing time and date but not pulled in the initial draw. Drawing for the alternate list will immediately follow the drawing for entries which are to run.

Notification: Notification of the draw results will be made as soon as possible after entries have closed. Should such notification not be received within a reasonable time, the exhibitor should contact the Test Secretary.

Refund policy: The entry fee shall be refunded to any entrant if the secretary is notified of such withdrawal prior to the draw and an alternate is available to run the track, and for all alternates not given the opportunity to run a track.

Bitches in season may participate: If you know that your bitch will be in season the day of the test, notify the test secretary ahead of time. When you arrive at the test site, park your vehicle away from the other cars and notify the test secretary that your entered bitch is in season. The last track to be laid will be reserved for the bitch in season. If there is more than one bitch in season, a second draw for those bitches will be held. Bitches in season will only be allowed to participate after all other dogs and bitches not in season have been tested. Bitches in season must be kept away from the rest of the entered dogs. Failure to comply will result in the handler and dog being excused from the test site and any award withheld.

Draw for running order: All entrants must be at the test site by 7:00 AM the morning of the test, at which time there will be a draw for running order. Entrants not present at that time will be marked absent and an alternate will be allowed to run in their place. The test secretary will have her cell phone turned on at the test site: (530) 400-3454

Judging: Will begin as soon as tracks have aged sufficiently.

Awards: A dark green qualifying ribbon and a rosette personalized with the dogs name will be awarded to each passing dog.

Dogs on leash: All dogs and bitches entered in this test must be kept on leash at all times. Failure to comply will result in the dog and handler being excused from the test site and the withholding of any awards. This also applies to any non-entered dogs that may accompany anyone at this test.

Practicing in the fields: The areas we are allowed to use are anything on the right after you turn onto Eagles Nest Road all the way to Woodring Road, and anything on the left past the golf course. Please do not use the area on the right beyond (south of) Woodring as dogs are no longer allowed in that area.

Exhibitors should follow their veterinarian's recommendation to insure their dogs are free of internal and external parasites and communicable diseases and have appropriate vaccinations. Rabies vaccine is required in the State of California. Do not leave any dogs in closed vehicles. If any dog is seen to be suffering from extreme temperatures or is confined without supervision, the authorities will be notified to handle the situation. Violators may be reported to the Test Committee for disciplinary action. All persons attending this test hereby waive any claim for damages against TRACS or its members in the event a motor vehicle must be entered to rescue a dog from overheating or suffocation due to improper ventilation.

Parking: The parking lot requires a daily use fee of \$4.00 per car.

- The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements of a championship, but whose championships are unconfirmed.
