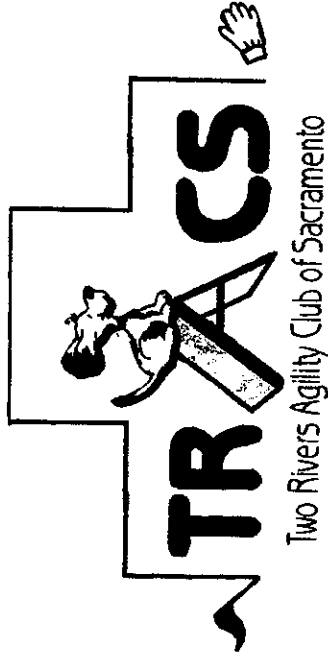

Closing Date: Entries will be accepted until 5:00 PM on Thursday, February 11, 2010 after which time entries will not be accepted, canceled, altered or substituted. All entries must be delivered to Sue Bailey, 226 Jalisco Pl, Davis, CA 95616. Overnight and express mail entries **MUST** specify **NO SIGNATURE REQUIRED**.

Entry Fee: \$60.00. Make checks payable to TRACS. A \$.50 recording fee and \$3.00 event service fee is included in each entry fee and will be forwarded to the AKC per Ch. 11, Sec. 2 of the AKC Rules and Regulations

Certification: Each entry for a dog that has not previously passed an AKC Tracking Dog Test must be accompanied by a written statement, dated within one year of the date of the test, signed by a person approved by AKC to judge tracking tests, and certifying the dog has satisfactorily performed a certification test. Certifications will be returned to entrants who do not run their dogs in this test.

Tracking Test Entries: Dogs holding the title of Tracking Dog shall not be excluded from competition; however, the Test Secretary will give preference to dogs not having a TD. Entries are limited to 12 dogs.

Entry Draw: To determine which entrants will participate in the test, a random drawing of all entries received by the closing time and date will take place on Thursday, February 11th at 7:00 PM at Cindy's Restaurant, 4823, Chiles Rd (at Mace Blvd), Davis, CA.

Alternate List Draw: Immediately following the entry draw, a random drawing of the undrawn entries will take place to create a numbered alternate list.

Notification: Notification of the results of the draws will be made as soon as possible after entries have closed. Exhibitors who have not received notification within a reasonable time should contact the Test Secretary.

Refund policy: The entry fee shall be refunded to any entrant if the Test Secretary is notified of entry withdrawal prior to the entry draw and an alternate is available to run the track. All alternates not given the opportunity to run a track will receive a refund of their entry fee.

Draw for running order: All entrants must be at the test site by 7:00 AM the morning of the test, at which time there will be a draw for running order. Entrants not present at that time will be marked absent and an alternate will be allowed to draw and run in their place.

Bitches in season may participate. If you know that your bitch will be in season the day of the test, notify the Test Secretary ahead of time. When you arrive at the test site, park your vehicle away from the other cars and notify the Test Secretary that your entered bitch is in season. The last track to be laid will be reserved for the bitch in season. If there is more than one bitch in season, a separate running order draw for those bitches will be held. Bitches in season must be kept away from the rest of the entered dogs, and will be allowed to participate only after all other entered dogs have been tested. Failure to comply will result in the handler and bitch being excused from the test site and any award withheld.

Judging will begin as soon as tracks have sufficiently aged.

Awards: A dark green qualifying ribbon and a rosette will be awarded to each passing dog, as well as the articles found on the track.

Dogs on leash: All dogs and bitches entered in this test must be kept on leash at all times. Failure to comply will result in the dog and handler being excused from the test site and any award being withheld. This also applies to any non-entered dogs that may accompany anyone at this test.

Directions to test site: From Sacramento take Hwy 50 towards Placerville. Take the Sunrise Blvd. South exit and go 4 miles to Douglas Rd. Turn right onto Douglas Rd. and go 1 mile to Eagles Nest Rd. Turn left onto Eagles Nest Rd. Go 2/10 mile and turn left into Mather Field Rotary Park where we will meet at the Gazebo for the draw.
From Placerville take Hwy 50 towards Sacramento and follow the above directions.

Parking: The Park requires a daily use fee of \$6.00 per car per day.

Practicing is allowed in the fields. The areas we are allowed to use are anything on the right after you turn onto Eagles Nest all the way to Woodring Rd. and anything on the left past the golf course. Please do not use the area on the right beyond Woodring as dogs are no longer allowed in that area. The fields should **NOT** be used on weekends when tracking tests are scheduled. Check the AKC Events or TRACS websites for those dates.

Exhibitors should follow their veterinarian's recommendation to insure their dogs are free of internal and external parasites and communicable diseases and have appropriate vaccinations. Rabies vaccine is required in the State of California. Do not leave any dogs in closed vehicles. If any dog is seen to be suffering from extreme temperatures or is confined without supervision, the authorities will be notified to handle the situation. Violators may be reported to the Test Committee for disciplinary action. All persons attending this test hereby waive any claim for damages against TRACS or its members in the event a motor vehicle must be entered to rescue a dog from over-heating or suffocation due to improper ventilation.

INSTRUCTIONS:

- (Variety) If you are entering a dog of a breed in which there are varieties for show purposes, please designate the particular variety you are entering i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., Over 13 in. But not exceeding 15 in.), Dachshunds (long-haired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahua (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division the class in which you are entering your dog, i.e., age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner, it must be entered in the name of its new owner in any show for which entries closed after the date of acquisition, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to AKC. (For complete rules, refer to Chapter 11, Section 3.)

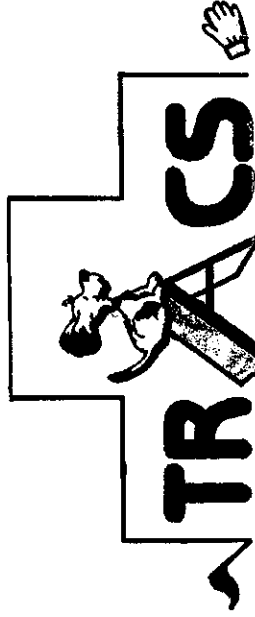
