

**Refund Policy:** The entry fee shall be refunded to any entrant if the secretary is notified in writing prior to the draw of such withdrawal and an alternate is available to run the track. All alternates not given the opportunity to run a track will receive a refund of their entry fees.

**Bitches in season may participate:** if you know that your bitch will be in season the day of the test, notify the test secretary ahead of time. When you arrive at the test site, park your vehicle away from the other cars and notify the test secretary that your entered bitch is in season. The last track to be laid will be reserved for the bitch in season. If there is more than one bitch in season, a second draw for those bitches will be held. Bitches in season will only be allowed to participate after all other dogs and bitches not in season have been tested. They must be kept away from the rest of the entered dogs. Failure to comply will result in the handler and dog being excused from the test site and any award withheld.

**Draw for running order:** All entrants must be at the test site by 7:00 am the morning of the test at which time there will be a draw for running order. Entrants not present at that time will be marked absent and an alternate will be allowed to run in their place.

**Judging** will begin as soon as tracks have sufficiently aged

**Awards:** A dark green qualifying ribbon, a rosette, and a digital photograph will be awarded to each passing team.

**Dogs on leash:** All dogs and bitches entered in this test must be kept on leash at all times. Failure to comply will result in the dog and handler being excused from the test site. This also applies to any non-entered dogs that may accompany anyone at this test.

**Practicing is allowed in the fields at Mather.** The area we are allowed to use is on the right of Zinfandel (formerly Eagles Nest Road) between Douglas and Woodring Roads. Please do not use the area to the south of Woodring as dogs are not allowed in this area.

**Practicing is NOT allowed in the fields on a test weekend.** Please observe the "no dogs" signs in the restricted use areas.

**Worker Option:** Two TD tracks will be reserved for test workers who earned required credit. If necessary a random drawing may be held to determine which test worker is chosen. The remaining workers will automatically be included in the drawing with the other entries received.

**Directions to test site:** From Sacramento take Hwy 50 towards Placerville. Take Sunrise Blvd. South exit and go 4 miles to Douglas Rd. Turn right on Douglas Rd. and go 1 mile to Zinfandel Rd. Turn left on Eagles Nest Rd. Go 2/10 mile and turn left into Mather Field Rotary Park where we will meet for the draw. From Placerville take Hwy 50 towards Sacramento and follow the above directions.
