**CLOSING DATE:** Entries will be accepted until 6:00 PM on Thursday, February 5, 2026, after which time entries will not be accepted, canceled, altered or substituted. Overnight and express mail entries **MUST** specify **NO SIGNATURE REQUIRED**.

**ENTRY FEE:** \$75.00 payable in US dollars (includes \$0.50 AKC recording fee and \$3.00 event fee). Make checks payable to TRACS.

**CERTIFICATION:** Each entry for a dog that has not previously passed an AKC Tracking Dog Test must be accompanied by a written statement dated within one year of the test date, signed by a person approved by AKC to judge tracking tests, and must certify that the dog has satisfactorily performed a certification test. Certifications will be returned to the entrants who do not run their dogs in this test.

**ELIGIBILITY:** Test is limited to 6 dogs with appropriate Certification. All AKC-Registered dogs are eligible to enter this test. A dog may participate in this test after it has earned the TD (or any other) tracking title. Priority shall be given to dogs that do not hold an AKC tracking title.

**DRAW FOR ENTRY:** A random drawing of all entries received by the closing date and time will take place to determine which entries will participate in the test. The drawing will be at 6:15 PM on Thursday, February 5, 2026, at Starbucks, located at 2000 El Camino Real, Palo Alto CA 94306.

**TEST WORKER OPTION:** Two (2) tracks will be reserved for test workers who have earned sufficient required credit at past TRACS/SDTC tests. If necessary, a random drawing may be held to determine which test worker is chosen. The remaining test worker entrants will automatically be included in the drawing with all the other tracking entries received. See the TRACS website at [agiltracs.org](http://agiltracs.org) for details of the test worker preference process.

**ALTERNATE LIST:** An alternate list will be maintained and will consist of entries received by the closing date but not pulled in the initial draw. Drawing for the alternate list will immediately follow the drawing for entries that are to run.

**REFUND POLICY:** The entry fee shall be refunded to any entrant if the secretary is notified prior to the draw of such withdrawal and an alternate is available to run the track, and for all alternates not given the opportunity to run a track.

**TEST HOURS:** 6:30 AM to 3:00 PM. Judging will begin as soon as tracks have aged sufficiently.

**DRAW FOR RUNNING ORDER:** All entrants must be at the test site by 8:00 AM the morning of the test, at which time there will be a draw for running order. Entrants not present at that time will be marked absent and an alternate will be allowed to run in their place.

**AWARDS:** A rosette ribbon will be awarded to each passing team.

**BITCHES IN SEASON:** If you know that your bitch will be in season the day of the test, notify the test secretary ahead of time. When you arrive at the test site, park your vehicle away from the other cars and notify the test secretary that your entered bitch is in season. The last track to be laid will be reserved for the bitch in season. If there is more than one bitch in season, a second draw for those bitches will be held. Bitches in season will only be allowed to participate after all other dogs and bitches not in season have been tested. They must be kept away from the rest of the entered dogs. Failure to comply will result in the handler and dog being excused from the test site and any award withheld.

**DOGS ON LEASH:** Dogs must be kept on leash at all times. Failure to comply will result in the dog and handler being excused from the test site and the withholding of any awards.

**DO NOT LEAVE ANY DOGS IN CLOSED VEHICLES.** If any dog is seen to be suffering from extreme temperatures or is confined without supervision, the authorities will be notified to handle the situation. Violators may be reported to the bench show Committee for disciplinary action. All persons attending this show hereby waive any claim against TRACS and its members, in the event a motor vehicle must be entered to rescue a dog from over-heating or suffocation due to improper ventilation.

**RISK:** The owner or agent entering a dog in a Tracking Test does so at his/her own risk and agrees to abide by all the Rules and Regulations of the American Kennel Club. The Two Rivers Agility Club of Sacramento assumes no responsibility for any personal injury or death of any person; theft of personal property; theft, injury or death of any animal; or any loss of or damage to any property while at this test or on the test site or in transit to/from the site.

**VACCINATIONS:** Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites and communicable diseases and have appropriate vaccinations. Rabies vaccine is required in the State of California.

**ARBITRATION:** This club does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.

## DIRECTIONS TO TEST SITE

### NEW Location for "Headquarters"

From Highway 50 - Exit Zinfandel Dr. Travel south on Zinfandel Dr. Turn right onto Douglas Blvd. At the stop sign, (Mather Blvd.), turn left. Turn left onto Convair Liner Rd. (yellow gates). There are no restroom facilities at this location. Facilities are located at Mather Regional Park (Zinfandel Dr.), Mather Golf Course (Zinfandel Dr.), or local park (10949 Britton Way, Mather, CA).

There are no restrooms at the test headquarters. Plan on using the restrooms at the Mather Rotary Park (old HQ, be aware of the parking fee), or at the Mather Golf Course, or at Veterans Park on Excelsior Rd a mile past Convair Liner Rd. Please plan on using restrooms prior to your arrival, as entry/exit access to Convair Liner Rd will be limited once testing has begun.

**SPECTATOR/DRIVING ACCESS.** We are no longer officially allowed any vehicle access on any of the interior roads. We will likely need to drive to the west side of the park when staging for some of the tracks, and there is likely to be a significant walk for exhibitors and spectators (if allowed) into and out of the areas. **In addition, the area available for exercising dogs during the event has changed** - please look for marked area and/or inquire before exercising your dog at the site.

**PRACTICING:** Limited practicing on the test site is permitted with these restrictions. No training on the grounds is permitted on the day of the test. Please refrain from using the fields at least 3 days before the test. Please respect all "No Dogs" posted signs.



### IMPORTANT - 10-DAY RULE

- No exhibitor may show a dog under a judge at a tracking test if the exhibitor has participated in a training session taught by that judge within ten (10) days prior to the date of the event (Chap 1, Section 12, paragraph 8).
- People cannot act as tracklayers for dogs if, within the past 10 days, they have boarded, laid a track for, or regularly trained the dogs whose tracks they are to lay. The tracklayer must not be a person with whom the dog has resided or a member of the household or a member of the immediate family of the dog's handler. The judges will determine the order in which the tracks are run and the number of each track. (Chap 2, Section 9, paragraph 4).

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Dog Show Class) Consult the classification in this premium list. If the dog show class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e, age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for a show closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name.
