Draw for Entry: A random drawing of all entries received by the closing time and date to determine which entries will participate in the test will take place on Wednesday, August 3, 2005 at 7:35 PM at Merryhill Preparatory School, 7334 Park City Drive, Sacramento, CA 95831

Alternate List: An alternate list will be maintained and will consist of entries received by the closing date but not pulled in the initial draw. Drawing for the alternate list will immediately follow the drawing for entries which are to run.

Bitches in season may participate: If you know that your bitch will be in season the day of the test, notify the match secretary ahead of time. When you arrive at the test site, park your vehicle away from the other cars and notify the match secretary that your entered bitch is in season. The last track to be laid will be reserved for the bitch in season. If there is more than one bitch in season, a second draw for those bitches will be held. Bitches in season will only be allowed to participate after all other dogs and bitches not in season have been tested. They must be kept away from the rest of the entered dogs. Failure to comply will result in the handler and dog being excused from the test site and any award withheld.

Dogs in Vehicles: Do not leave any dogs in closed vehicles. If any dog is seen to be suffering from extreme temperatures or is confined without supervision, the authorities will be notified to handle the situation. Violators may be reported to the sponsoring club for disciplinary action.
